



Hi Neil.

Please see notes as requested for your minutes from my presentation on the 17th November.

In your draft minutes you have covered the VLPA searching for a new Lab.

Over the past 12/15 months the VLPA has had meetings and discussions with various personal within the Chemical Analytical and Research areas, with regard to Limestone Testing.

We met with Dr Ken Peverill who made these points;

With the Vic. Fertiliser Regs. the ENV requirement was removed. However in other States it retained and their standards were more rigorous than those in Victoria. The

Vic. standards were less rigorous to reflect the common softer nature of Vic. limes.

Rather than try to develop a new test for soft limes (which would take a lot of time and money) it might be best to look at various approaches.

The VLPA would have to set protocols for field sampling, sub-sampling for analysis, fractionation and calculation of relative value. The lab. reports at present do not address this, or even calculate a value for ENV.

I had a long telephone conversation with Bruce Shelley, Senior Research Scientist | Group Leader – Inorganic Chemistry | Site leader | Agriculture Victoria Research Division, who made these points:

With regard to soil acidity it is not just about pH, but also the soil, and what is being grown, and quality and source of the limestone.

Temperature of the soil effects and pH increase in the soil.

Water logged soil, or to dry soil, effects the physics of the liming response.

The original ENV Vic. lab. trials were mainly involved with hard sourced limestone and were conducted in controlled conditions, without field trials. (and maybe not that reliable)

Bruce suggested if the ENV was revisited as an indicator of lime quality, maybe five fraction sizing's may be required. Also, a new project for lime research is currently being undertaken with team leader Nathan Robinson.

The Chairman, Mark Malone, Committee Member, Greg Williams, of the VLPA and myself met with Mr Bruce Shelley.

Some of the points made are listed below:

When testing limestone, wet sieving is better to assist particle distribution.

The "effects" of applying limestone and gypsum at the same time? T Tovey to get an analytical report.

Lime trials in Southern NSW, which included both hard and soft limestone, and were incorporated, saw some of the following results.

The softer/earthy limestone performed 20% better than predicted.

By 12/24 months most differences in the trial results were attenuated, for 10 of the 12 limes in the trial. T Tovey to get permission for the results of this trial to be distributed to AFSA members.
